B. The next meeting is scheduled for Tuesday, December 15, 2015 at 2:45 P.M. in the Middle / High School.

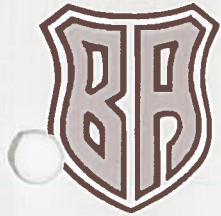
V. ADJOURNMENT
